# Reaching Beyond RURA

Online access and opportunities for rural communities continue to increase every day. Shopping online or video chatting with a relative are common practices. However, South Dakotans are using their broadband Internet in many other interesting ways, as well.

In Golden West's 2018 Annual Report, we briefly introduced Tara Currier-Hofer, JT Rickenbach and Joyce Wheeler. Let's take a closer look at this teacher. rancher and great-grandmother to see how they use their broadband Internet connections to reach well beyond their rural locations.

#### Tara Currier-Hofer Bridgewater, SD: Teacher & Magician

While Bridgewater resident Tara Currier-Hofer isn't a magician in the traditional sense of the word, what she does on a daily basis really is quite amazing. Each morning, Tara takes 60 steps from the back door of her farmhouse to work. Her office is a simple building, much like the others in the farmyard, except for the old school bell hanging by the door.

"I used to play school with my stuffed animals in my bedroom as a child," recalls Tara. "I was not funny enough to be a comedian, not flexible enough to be a ballerina, and I couldn't stand the sight of blood, so being a dentist was out of the question."

Perhaps even more incredible than pulling a rabbit out of a hat, today Tara uses the Internet to teach Spanish to high school students across South Dakota.

"Having Golden West services in rural Bridgewater means that I am able to teach from my home office. I instruct hundreds of students, who otherwise would not have the opportunity to learn Spanish," explains Tara. She teaches via the Dakota Digital Network (DDN), reaching students through Northern State University's E-learning Program.

In her 26th year of teaching and her sixth with DDN, Tara will teach Level 1 and 2 Spanish to over 100 students in 14 high schools this year. She'll do it all from home, in a small office located on a farmyard in rural Bridgewater. Tara the magician indeed.

#### JT Rickenbach

Oelrichs, SD: Rancher & International Businessman

Born and raised in Oelrichs, JT Rickenbach is all rancher. He's got the hat and pearl-snap buttons on his shirt, and his wife, Sara, owns and operates Rancher Feed & Seed in nearby Buffalo Gap. All initial signs point toward a typical ranch family, but this one has international connections.

#### Joyce Wheeler Philip, SD: Great-Grandmother & Author

Longtime Philip area resident Joyce Wheeler has lived on a South Dakota ranch her whole life. She and her husband, Justin, operated a cattle ranch and raised four kids. Today their family has grown to include 10 grandchildren and four great-grandchildren.

"From being a rancher's daughter to a rancher's wife, I've been involved in the challenges of raising cattle, ranch work and the variables that nature brings," says Joyce. Raising children and running cattle took time - a lot of time - with little left for hobbies. She began to pursue her lifelong dream of writing christian/western fiction novels about 10 years ago.

"I actually kept the manuscript of my first book in a drawer for over a year before I contacted a publisher," says

#### JT Rickenbach continued:

"I went to the South Dakota School of Mines and got a Bachelor of Science in Mechanical Engineering," says JT. "My second job out of school was with Midcom in Watertown manufacturing electronic components for telecommunication and data communication companies."

This led JT back home to start his own company. His idea was to build the same type of electrical components as a contractor for Midcom and other similar companies.

"In 2002, I started WESTROM in Hot Springs, while still being able to live and ranch with my family in Oelrichs," says JT. "WESTROM builds electronics, cases and housings for electronics, and the machines to build electronics. We build electronics. We don't design electronics."

WESTROM boasts two locations - one in Hot Springs and another in Hong Kong. "Most electronic component

Visit westrom.net to learn more about JT's business. manufacturing and consumer electronics are built in south China," explains JT. "It's similar to gold prospecting in that you have to go where the gold is."

As you can imagine, most of JT's business is outside of South Dakota and the United States, but there are

Joyce. After the first two publishinghouses she used closed their doors, Joyce decided to self-publish. She works one-on-one via the Internet with a company in Florida called BookLocker. "For the first time, I can directly contact the cover designer or the publisher, making the whole process simple and quick," she says.

Joyce fully embraces her passion for writing and selling books, and her location on a cattle ranch outside of Philip does not stand in her way.

While she receives publishing help from Florida, Joyce relies on local help for marketing her books and website. "I have a great web designer that lives in Rapid, and while I've never met him, we communicate easily because of the reliability of emails," says Joyce.

As Joyce puts it, "In this beautiful and sometimes frustrating age of technology, writing and publishing books are somewhat easy in our rural area with the aid of Golden West Internet."

advantages to operating a business from Hot Springs. "Western South Dakota has good Internet, commercial airline service out of Rapid City, and the School of Mines has good university support if I need it," details JT.

Despite the distance to most of his customers, JT knows he made the right decision to live and work in South Dakota. "I wanted to raise my kids with the same idea of normal as I did. They all graduated from Hot Springs High School and think of this area as home. It has all worked out pretty well."



# **Annual Meeting MINUTES**

The Annual Meeting of the members of Golden West Telecommunications Cooperative, Inc., was called to order at 1:00 p.m., September 23, 2017 at the Wall Community Center, Wall, South Dakota by President Jeff Nielsen. Said meeting was held pursuant to notice thereof as required by law. The Nesters sang the National Anthem. The Pledge of Allegiance was led by President Nielsen.

President Nielsen called upon Darla Pollman Rogers, Attorney for the Cooperative, who gave the Credential Report. A motion was made and seconded to approve a quorum. Motion carried.

Next, President Nielsen called upon Kenneth Zickrick, Jr., Secretary, to read the Notice of Meeting and the Proof of Mailing, after which a certified copy of each was duly filed as part of the Minutes of this meeting.

President Nielsen introduced the special guests in attendance at the meeting.

President Nielsen welcomed the Cooperative members and asked that the minutes of the 2016 Annual Meeting be approved, if there were no additions or corrections, as written. On a motion duly made, seconded and unanimously carried, the President declared the Minutes approved.

A motion was made, seconded and carried to approve the financial report.

President Nielsen then delivered his presidential report. He introduced the Golden West Board of Directors, and gave an update on the services and history of Golden West. He talked about the progress of Golden West and the many connections that the cooperative shares with its members.

Next, President Nielsen called on Denny Law, General Manager/CEO, to present his annual report. Mr. Law welcomed all in attendance. He reported on the advantages of fiber optics and the upgrades that will strengthen Golden West's broadband services in the future. Mr. Law then reported on Golden West's advocacy for its members, as well as FCC Chairman Pai's visit to Golden West. He then highlighted the importance of Golden West's scholarship and economic development grant programs. Mr. Law also spoke about how Golden West employees are involved in their communities through civic and volunteer participation.

President Nielsen called on Darla Pollman Rogers, attorney, to report on the nominating petitions for the Board of Directors. Vacancies on the Board of Directors were as follows:

District I – Jade Hlavka (four-year term) one vacancy with one candidate

District IV -Kenneth Zickrick, Jr (four-year term) one vacancy with one candidate

District VI – (four-year term) one vacancy with two candidates - Dale Guptill and Sam O'Rourke

District VII - Bart Birkeland (four-year term) one vacancy with one candidate

A motion was made, seconded and carried to seat the uncontested incumbents: District I: Jade Hlavka

District IV: Kenneth Zickrick, Jr District VII: Bart Birkeland

Darla Pollman Rogers, attorney, introduced the director candidates for District VI: Dale Guptill and Sam O'Rourke. Each candidate was allotted three minutes to address the membership. Next, Darla Pollman Rogers advised the membership of the balloting process and requested that the ballots for the election of directors be handed out. After the membership had the opportunity to vote, the ballots were collected. A three-member balloting committee was appointed by Darla Pollman Rogers to oversee the ballot counting and report to the membership. The members of the balloting committee were Earle Geide, Cynthia Plenty Bull and Betty Zolnowsky.

President Nielsen called for any old business. There was none.

President Nielsen called for any new business. A question was asked about battery life on fiber optics equipment. A former employee inquired about current employee benefits. Rosebud Tribal Utilities Commissioner Ronald Neiss complimented Golden West on its annual meetings.
